2016-2017 UC IRVINE/EDISON INTERNATIONAL SCHOLARSHIP

Building on existing efforts to improve transfer rates, the University of California and Edison International will offer scholarships to LSAMP-CAMP eligible community college transfer students majoring in Computer Sciences, Computer Engineering, Environmental Science, Electrical Engineering, Mechanical Engineering, Civil Engineering, and Industrial Engineering. Students must reside within a Southern California Edison Service area OR be enrolled at a community college served by Southern California Edison. Please see attached list of eligible community colleges.

The scholarship supports promising UC Irvine students with a conditionally-renewable \$7,500 scholarship per year for two-years should the scholar maintain GPA requirements and complete 25 hours of community service per year through the LSAMP-CAMP UC Irvine office (UC Irvine Center for Educational Partnerships). ELIGIBILITY REQUIREMENTS:

- CA Community College transfer student who enrolled at UC Irvine starting Fall 2016.
- Minimum 3.0 GPA for Community College & UCI.
- Declared Science major in the following disciplines: Computer Sciences, Computer Engineering, Environmental Sciences, Electrical Engineering, Mechanical Engineering, Civil Engineering, and Industrial Engineering.
- **Financial need as determined by the UC Irvine Office of Financial Aid and Scholarships.**
- Must reside within a Southern California Edison Service area OR be enrolled at a community college served by Southern California Edison.
- U.S Citizen or Permanent Resident
- One letter of recommendation (maximum of three letters may be submitted). Letter of recommendation must be from a current or former college professor or academic counselor.
- Transcripts from all college work completed and work in progress report. Unofficial transcripts will suffice.

A complete application includes:

- Submission of a signed UC Irvine/ Edison International Scholarship application including your personal statement.
- One letter of recommendation (maximum of three letters may be submitted).
- Transcripts from all college work completed and work in progress report. Unofficial transcripts will suffice.
- Filing a 2017-2018 Free Application for Federal Student Aid (FAFSA). The FAFSA can be filed at www.fafsa.gov.
- Students who did not enroll at a community college served by Southern California Edison must provide a copy of their Southern California Edison's (SCE) bill to prove she/he lives in a service area to be eligible for this scholarship.
